HealthSmart Completes Purchase Agreement with American CareSource Holdings, Inc.

(Dallas, Texas) January 19, 2017 — HealthSmart, a leading independent provider of managed care solutions for self-funded employers across the country, announced today that it has completed its asset purchase agreement with American CareSource Holdings, Inc. ("Company"). HealthSmart purchased the assets of Ancillary Care Services, Inc., a nationwide ancillary healthcare provider network. The transaction included certain other specified assets and contracts from the Company and two of its wholly-owned subsidiaries related to the Company's ancillary network business. The transaction did not include the Company's urgent care and primary care business and excluded other mutually agreed assets and liabilities.
